Following qualification he worked in McGrigors LLP's Energy and Infrastructure Projects Team, where he specialised in downstream energy projects of all types (including onshore wind, offshore wind, solar pv, anaerobic digestion and energy from waste) advising projects developers, project sponsors, funders and regulated utilities.

In 2012 Andrew completed a 9 month secondment to the legal team at ScottishPower Renewables before joining Swedish Utility, Vattenfall, as UK Legal Counsel. During his time at Vattenfall, Andrew advised on the development, construction and operation of Vattenfall's portfolio of onshore and offshore wind farms, including advice on a number of complex regulatory and grid connection related matters.

Andrew further developed his legal and commercial expertise in 2015 when he joined ScottishPower as a solicitor in SP Energy Networks, being responsible for regulatory and commercial legal matters. From 2018 until April 2022 Andrew was also the Secretary of the Scottish Power Energy Networks Holdings Limited Audit and Compliance Committee.

In May 2022 Andrew was appointed to the group role of Legal Director – Regulation, the position he currently holds. Andrew leads and manages the UK Regulation legal team and is responsible for the provision and management of legal advice on regulatory issues at Board, Executive Team and senior management team level.
