## **1** Introduction

This specification comprises general requirements for the Approval and testing of fasteners and washers for wood pole overhead lines employed on the electricity distribution network owned by Electricity North West Limited (Electricity North West). Also included are technical particulars relating to the constructional requirements and a schedule of all fasteners and washers in alphanumeric order (Appendix A).

## 2 Scope

This specification covers all fasteners and washers required for the construction of overhead lines on wood poles (from LV to 132kV).

## **3** Definitions

### 4 General Requirements for Approvals and Testing

#### 4.1 Product not to be Changed

No change in the product, packaging or labelling shall be made after Approval has been granted without prior notice to the Electricity North West Overhead Circuits Manager, and receipt of a written agreement to the proposed change from the Electricity North West Overhead Circuits Manager.

#### 4.2 Electricity North West Technical Approval

The Tenderer shall submit, with this Tender, proposals for testing which will demonstrate, to the satisfaction of the Electricity North West Overhead Circuits Manager, compliance with this Specification. Such tests shall be carried out without expense to Electricity North West.

Alternatively, technical reports and other data may be submitted that the Tenderer considers will demonstrate, to the satisfaction of the Electricity North West Overhead Circuits Manager, compliance with this Specification. Acceptance of this evidence shall be at the discretion of the Electricity North West Overhead Circuits Manager but will not be unreasonably withheld.

Approval shall be 'factory specific' and is not transferable to another factory without the written Approval of the Electricity North West Overhead Circuits Manager.

The Supplier and product shall comply with all the relevant requirements of Electricity North West documents EPD311 and CP311.

#### 4.3 Quality Assurance

The Tenderer shall confirm whether or not Approval is held in accordance with a quality assurance scheme accredited under ISO 9000. If not, the Tenderer shall submit a statement of the quality assurance procedures employed to control the quality of the product, including the performance of Suppliers and Sub-Contractors.

The right is reserved for the repeat of such tests, from time to time, that the Electricity North West Overhead Circuits Manager may deem to be reasonably necessary to demonstrate continued compliance with the Specification.

The Tenderer shall submit, with the Tender, a list of tests and inspections which are carried out on the product prior to despatch which shall demonstrate, to the satisfaction of the Electricity North West Overhead Circuits Manager, fitness for installation and service.

The Tenderer shall provide free of charge to Electricity North West such samples as may, in the opinion of the Electricity North West Overhead Circuits Manager, be reasonably required for inspection and/or retention as quality control samples. The Electricity North West Overhead Circuits Manager will confirm the requirement for samples at the time of Tendering.

The right is reserved for inspections to be made of Tenderer's facilities, from time to time, as deemed reasonably necessary by the Electricity North West Overhead Circuits Manager to ensure compliance with this Specification and any Contract of which it forms a part.

The Tenderer shall submit, with the Tender, such details of product packaging disposal, as will enable Electricity North West to comply with the requirements of BS EN ISO 14001 - Environmental Management Systems.

#### 4.4 Formulation

The Tenderer shall submit, with the Tender, such details of the formulation and use of the product and associated substances as will enable Electricity North West to comply with the obligations of the Health and Safety at Work Act 1974 and the Control of Substances Hazardous to Health Regulations 2002, in the use, storage and disposal of the product. The Tenderer may stipulate, prior to submission of such information, that it is to remain confidential, and the Electricity North West Overhead Circuits Manager will, if requested, confirm agreement to this prior to receipt of the information.

#### 4.5 Identification Markings

The Tenderer shall submit, with the Tender, details of markings which it is proposed to apply to the product or packaging to identify manufacturing batches or items. The forms and content of such markings shall be subject to the Approval of the Electricity North West Overhead Circuits Manager and shall in all cases include the Electricity North West approved description and commodity code number.

The Tenderer shall submit, with the Tender, such details of marking gross weight on components, assemblies and packages, as will enable Electricity North West to comply with the Health and Safety Manual Handling Operation Regulations 1992, for components, assemblies and packages supplied with a gross weight over 1kg. The forms and content of such markings shall be subject to the Approval of the Electricity North West Overhead Circuits Manager.

#### 4.6 Minimum Life Expectancy

The minimum life expectancy of all products covered by this Specification is 75 years.

#### 4.7 **Product Conformity**

Preference will be given to those Suppliers who can provide suitable product conformity certification to a recognised or specified standard, or an equivalent certification.

#### 5 Requirements for Type and Routine Testing

The Electricity North West Overhead Circuits Manager shall set out the requirement of the following tests to be carried out by the Supplier at the Supplier's cost.

#### 5.1 Requirement for Type Tests at Suppliers Premises

These are a series of one-off type tests, which are carried out to ensure the satisfactory performance of the product design, under extremes of operating stresses, and of endurance, as may be appropriate, to be determined by the Electricity North West Overhead Circuits Manager.

These may or may not be destructive tests.

#### 5.2 Requirement for Routine Tests at the Supplier's Premises

These tests may be required to be carried out on every individual unit or component, as specified, or at some regular frequency to be determined by the Electricity North West Overhead Circuits Manager.

The results of these tests may be required to be supplied to Electricity North West with each unit purchased or retained for inspection, at a period to be determined by the Electricity North West Overhead Circuits Manager.

## 6 Constructional Requirements

All fasteners and washers covered by this specification are listed in Appendix A.

Fasteners and washers shall conform to all requirements of this specification and ENA TS 43-96 (Fasteners and washers for wood pole overhead lines). Manufacturing tolerances shall be those given in ENA TS 43-96, unless otherwise stated. Note that "washers, round, flat...galvanized" shall comply with BS 4320, Table 3 (Black washers – Normal diameter. Metric series (Form E)).

Bolt, pole step (CC 139387) shall be high tensile steel, grade 8.8.

Steel nails (including staples) shall comply with BS 1202-1: 2002.

All steel items, unless stated otherwise, shall be galvanized to BS EN ISO 1461. Galvanized steelwork shall be free from sharp edges or points left by the galvanization process.

Ties (security, plastic type) shall be manufactured from plastic, nylon, or similar, to meet the requirements for non-metallic ties given in BS EN 50146.
