




CP319 – Applied High Voltage Test Requirements


- Update to Procedure A10 Changes for reference to CP424-2. Amendment to Appendix B regarding VZ felling. Appendix D update to LZ cutting. Appendix H – Tree Cutting POWRA revised.
- Update to Procedure B12 change to include Triplex 400mm2 cable and clamp for spiking. Removal of redundant YN68 A/2 lock from spiking gun box and replaced with Abloy padlock.
- Update to Procedure G09 change to require the pink copy of a Dangerous
 Occurrence Notice to be sent or emailed to the Health, Safety, Environment,
 and Quality (HSEQ) team for recording and tracking.
- Update to Procedure G19 change to allow the use of arc resistant undergarments under disposable coveralls when tower painting.
- Update to Procedure G20 reference changed to EPD283 (from CP331) for ELI values and fuse sizing.


- Updated to new CP template.
